

**Bank Account and Other Financial Institution Signature Authorization Policy**

The University of Arkansas, Fayetteville, has designated individuals holding the following positions to sign on the indicated accounts at the banks and other financial institutions denoted in the policy. These are established accounts that have been opened in accordance with University Board Policy.

Board Policy 305.1 states, “The President or Chief Fiscal Officer of the University of Arkansas is authorized to open the necessary bank accounts, signify appropriate signatures ... where required.”

The employees given signature authority are designated to make withdrawals and deposits (depending on the type of account which is indicated below), to facilitate payments to third parties that have been properly authorized under University procedures, to initiate transfers to another bank or other financial institution to the credit of the University of Arkansas, Fayetteville at that institution, and to give such instructions otherwise necessary for the normal and ordinary operation of the account.
